Jumpstart Presentation – Mark Harshberger

- Three completed this year (Centre, Lycoming and Blair counties)
- For seniors 55 and older that have vision loss
- Goal: client's become more self-sufficient and independent
- Socialization is an added benefit of the Jumpstart Program
- Includes Rehabilitation Teaching, Orientation/Mobility training and discussion groups (Eye Doctors, Access to Technology teachers and health professionals)

Question was asked if there is a similar program for younger people. Presenter explained that there is not right now but it is being discussed. Presenter also explained that there are summer camps for people in the younger age group.

Assistive Technology Presentation – Megan Farzati & Shasta Dreese

- There are three categories for Assistive Technology Low, Medium and High
- Low tech items in this category require little to no training (e.g.: pencil grip)
- Mid tech items in this category require some training and some cost (e.g.: voice recorder)
- Hi tech items in this category require training, higher cost and usually some maintenance (e.g.: smart pen)
- Presenter explained some AT equipment used in different categories of disability, including Deaf and Hard of Hearing, Fine Motor Skills disability, Low Vision disability and Learning disabilities
- Presenters demonstrated many of the items available
- Presenters listed local resources that help with AT
