  - (1) notifying persons with disabilities who are applicants for or recipients of services, including potentially eligible students for pre-employment transition services and individuals seeking employment at a subminimum wage, or their representatives, of the availability and purposes of CAP, including information on the means of requesting assistance under the program, and (2) requiring programs, including community rehabilitation programs, and projects that provide individuals with disabilities services under the Act, to inform such individuals of the

availability and purposes of CAP, including information on the means of requesting assistance under the program.
(3) CAP further recommends that OVR include the statutory language of Sec. 20 of the Rehabilitation Act of 1973 in OVR policies and procedures, including provider agreements, to ensure that agency and program staff are aware of the statutory CAP notification requirement.
