Discussion of State and Federal Legislation Submitted by Committee Members and Legislative Staff for Review

 Members reviewed the Watchlist via Zoom screen share and were provided the documents via email. Mr. Chris Todd (staff) presented the documents for member review.

- Ms. Michele Leahy inquired about legislation listed on the Federal Watchlist that
 covers the eligibility of spouses of veteran's educational benefits. Inquired about
 Federal legislation that proposes raising the 15-dollar minimum wage and
 explained the negative affects it may have on Social Security benefits unless it
 also includes provisions to increase substantial gainful activity, cost of living, and
 other associated issues. Inquired if there is a bill being proposed that increases the
 SSI \$2,000 limits. Asked staff to research and share with members legislation that
 may include those issues.
- Mr. Anthony McCloskey informed members the legislation proposes to remove the current 10-year limit placed on the eligibility of spouses of veterans to receive those benefits. Inquired if legislation was not proposed would it be appropriate for members to recommend that.
- Ms. Passle Helminski stated that would be appropriate, recommendations have been shared many times, instructed staff about searching for legislation.
