Craig Schield opened the meeting. Craig introduced Shad Goff, Executive Director of Celularity who presented on The Next Evolution in Cellular Medicine.

He presented on ophthalmology and optometry regarding degenerative diseases of the eyes.

A quick overview: They have been in business for 20 years and they focus on 3 items:

- 1. Procure placentas placentas are taken at the consent of the parents to help cure degenerative disease. Celularity maintains a procurement and cryopreservation facility. The placenta can then be used for cancer and other degenerative diseases.
- 2. Stem Cell Research to study brain cancer, GI cancer and non-Hodgkin's lymphoma. Stem cells are used from the placenta and umbilical cord.
- 3. Degenerative Disease Foot ulcers to chronic wounds and orthopedic surgeries up to the eyes.

Basically, the Company has all 3 facets within one Company. It is an 80 million dollars facility where a lot of research and development is performed.

One such procedure is BIOVANCE 3 – Ocular – Tri layer human Amniotic membrane.

In this procedure – the inflammatory response needs to be inhibited. Tested in a blind study to see how the cells importation to healing compare to competitors so the best cell friendly product can be brought to market.

The same process was done with the eye. Two products were compared that were already on the market, and their product was superior across the board with cell viability.

It can treat degenerative diseases of eyes and severe dry eye in patients. It provides a barrier to the eye lid from scraping and causing infection and helps with regenerative healing. The procedure is covered under insurance and priced accordingly.
