ATTENDEES:

1. REVIEW AND APPROVAL OF MINUTES:

- Minutes of the October 21, 2019, were approved.
- The group continued discussion on the need for formal minutes that should be posted on the Pennsylvania Rehabilitation Council website. Ms. Gonzalez did post the October agenda & minutes on the PaRC website. There was question on the wording of Providers and changing that wording to Community Resources.
