#### APPROVAL OF AGENDA AND PAST MINUTES

PA Workforce Development Updates Continued discussion regarding OFCCP and the availability of self-disclosure

# data to be shared with hiring departments for their required reports within the CareerLink system

- Mr. Christopher Manlove provided updates from PA Workforce Development including rapid response efforts for closures referred to the Department of Health and Human Services, tools to help serve Veterans and employers that hire Veterans, federal priorities regarding improving the digital intake process, referrals provided to OVR, management of the CWDS, quarterly site visits with local Workforce Development Boards and CareerLinks, and a virtual rapid response meeting regarding federal workers for adaptive service models to meet evolving needs. The rapid response services unit provides warning notices of potential closures or layoffs, meets with employees, helps with the application process for Unemployment Compensation (UC), shares CareerLink information, assistance with job applications, workshops, other job search tools, in-person customized assistance, referrals to OVR and the Department of Human Services, information about Foodbanks, and other supports. Information is also provided through their press office to the public through non-paid marketing and social media.
- Members inquired about a recent Executive Order to cut Workforce programs that are deemed ineffective. Mr. Manlove explained the Executive Order provides 90 days for evaluation of programs and 120 days for developing 1 million apprenticeships nationwide. There are currently 25,000 apprenticeships in the Commonwealth. No baseline or value analysis were provided to determine what are considered effective programs. Mr. Pennington requested that follow up regarding the Executive Order be included within the next meeting agenda.

### Office of Vocational Rehabilitation (OVR) Updates

 Mr. Rob Hodapp reported that OVR continues to partner with CareerLinks for disability trainings, accessibility checks, and ADA compliance assessments. OVR recently met with the Department of Corrections on how they can assist with employment for those with criminal records. OVR recently coordinated with District Offices in the northwest region of the state to conduct a walkthrough of a CareerLink facility that recently moved. Staff from the Bureau of Blindness and Visual Services (BBVS) are routinely present during CareerLink site visits to assess physical accessibility.
