## CITIZENS' ADVISORY COMMITTEE TO THE READING OVR DECEMBER 12th, 2023

## MEETING 1:00 PM TO 3:00PM VIRTUALLY OVER MICROSOFT TEAMS MINUTES

- 1. Call meeting to order.
  - Meeting was called to order at 1:05 PM
- 2. Introductions:
  - Attendance: 5 members, 3 OVR staff
  - Introductions: Angel Torres, Brian D'Amico, Andrew Pennington, McKenzie Hollenbach, Judy Yeasted, Kim Baskett, Jim Whitonis, Lee Buck
- 3. Review & approval of March, June and September 2023 meeting minutes:
  - A. Posting of minutes on the Pennsylvania Rehabilitation Council website after approval.
    - The committee was unable to approve the meeting minutes from March and June 2023 due to a lack of a quorum at the September 2023 meeting, therefore, the meeting minutes from March, June and September 2023 were approved today. Andrew moved to accept and Kim brought the 2nd motion. All were in agreement and minutes were accepted.
- 4. OVR Report: (Kim Baskett, Acting District Administrator)
  - A. Report on open or new cases with Reading District Office since last meeting and since the start of the fiscal year to see the trend in referrals. This will help track if outreach is meeting its goal.
    - For the program year 7/1/2023 and runs to 6/30/2024:
    - Numbers reported are valid 7/1/23 11/30/23
    - 559 referrals (exceeds # of 416 for same period in 2022) & increasing each month.
    - VRC's receiving high # of referrals monthly; 13 15 avg. Should be 8 10.
    - 293 initial interviews / intake appointments successfully held
    - This number reflects cases moved to status 02 to date, not the total number of initial interviews conducted. The discrepancy is due to case processing delays and successful return of Rights & Responsibilities document (OVR-11).
    - 366 eligibilities determined
    - 298 initial IPEs completed
    - 166 IPE amendments
    - 52 successful Status 26 closures goal is 186. Expect increase in Dec
    - Current # of cases in Status 06 added to minutes per request by Andrew Pennington 9 cases
    - Staffing:
    - 12 VR Counselor positions filled
    - 6 of 12 are less than 2 years (1 is less than 1 year)
    - 5 of those 6 are not yet at full-caseload capacity
    - 3 Open VRC positions approved to be filled
    - VR Supervisor 1 experienced filled, 1 TWOC filled, 1 vacancy not yet approved to be filled
    - 1 ADA position not yet approved to be filled
    - 2 Business Services Representative positions not yet approved to be filled
    - 1 DA position (Kim) filled permanently from TWOC in November
    - Rapid Engagement/Status 02 & 10 Compliance

- Referrals assigned to VRCs within 5 days
- Contact with customer occurs within next 5 days
- Most intake appointments taking place within 15 business days of referral assignment
- Question from CAC member "How is rapid engagement working for customers?" –
  Going well. Customers are instructed via written and verbal correspondence to bringing
  medical documentation to intake appointment. Quicker scheduling and early availability
  of medical records has led to higher compliance rates and starting customer services
  sooner. Example: In November the Reading DO had a 98% compliance rate for
  determining eligibility within 60 days of referral (status 02 10). Status 10 (initial IPE)
  compliance rate for November was 81% which is tracking upwards. RSA requires a
  minimum of 90% for both indicators.
- Question from CAC member: "How does presumptive eligibility work in rapid engagement especially for Social Security cases? What do you attribute increase in compliance to?"
- Supervisors meeting weekly with VRC's to track status 02 & 10 compliance
- Two aspects to eligibility: do they have a disability and determine order of selection (OOS). SSI/SSDI recipients are determined disabled and are automatically presumed eligible but VRC still needs to determine OOS. VRC's can change OOS later if additional medical documentation and diagnoses are discovered later in the process.
- Referrals come into the office but most are by phone. Referrals take clerical staff approx. 10 15 minutes to complete.
- Supervisor meet with VRC's monthly for full caseload tracking leading to monitoring all open cases, ensuring no one is overlooked and ensure quicker customer engagement and service delivery.
- Question from CAC member: "Is OVR under a waiting list?"
- No, there is no waiting list state-wide. Some offices are still experience significant staffing vacancies which is leading to certain areas being uncovered, or partially covered. Reading DO has vacancies in Schuylkill county. Those referral assignments are being delayed and are assigned to overtime VRCs as available. New VRC hires will be prioritized for Schuylkill County.
- Question from CAC member: "How many in vacant territory in Schuylkill?
- Currently there are approx. 110 referrals waiting, most are slated for assignment before Feb 2024, 39 of which are already being served on OT. We have two new VRC's in Schuylkill
- Question from CAC member: "Where to find job postings?" Employment Open Jobs (pa.gov)
- Staffing and vacant caseload updates will be provided in the next CAC meeting.
- CAC member suggestion: "Ca CAC put out a position paper from CAC perspective regarding what CAC sees as drawbacks and needs to get everyone seen/addressed timely & try to make needs better understood by Central Office?"
- All suggestions and feedback from the CAC is sent up through the chain of command by DA Kim Baskett.
- Assistant District Administrator and two Business Services Representative positions are still open
- No update on these positions since last CAC meeting
- 1 clerical position remains open
- This position will not be filled until the full complement of other positions is already staffed

  - Jim reached out other CAC chairs and had some interested in this.
  - OVR could host state-wide meeting via MS Teams or can use PaRC Zoom link.
  - Jim will reach out to chairs and provide details to local chair.
  - CAC Election
  - No email were returned with nominations for positions.
  - Concerns include low turn-out to meetings not having a chairperson may result in poor-quality meetings.
  - Angel wants to step down from his leadership position. Can he provide a hard-stop date?
  - Angel to email members a hard-stop date and reopen nominations for new voting date. Angel indicated March 12, 2024 as hard-stop.

  - Angel, Brian, and Kim will meet in Jan 2024 for interim meeting for planning purposes and to discuss agenda for next meeting.
